Introduction

Photopette[®] Photopette[®] is a handheld fixed-wavelength spectrophotometer for rapid, onspot analysis. It works together with a smartphone or computing device using a dedicated application which connects via a Bluetooth[™] link for taking measurements and data-transfer. It is a mobile, simple to use UV/VIS spectrophotometer instrument with a unique measurement tip (CuveTip[™]) coupled to a detector for accurate and precise measurement.

All Photopette[®] models can measure in small sample volume (45 μ l), without any sample loss. Due to its small footprint, Photopette[®] can conduct tests in a very small space setting such as a fume or cell culture hood.

All calculations for a measurement are performed by a mobile device through the Photopette[®] App. The App is designed for using different preprogrammed Application Types with a high degree of flexibility and accessibility.



Setup

Safety Information

Before commencing installation of the unit, please familiarize yourself with setup and operating procedures highlighted in this product guide. It is highly recommended that you go through all the warning labels and symbols on your instrument and their meaning. Please read the complete user manual prior to use.

Do not open the device as this can expose the operator to UV radiations and may damage delicate fiber optics.

IMPORTANT! Risk of UV light exposure device is used without CuveTips[™].

Do not use damaged cables, accessories and another peripheral with your Photopette[®].

Do not expose Photopette[®] to strong magnetic, electrical fields, water, chemicals or any type of liquid as heavy rain or moisture.

Do not put the device into fire, as it may swell or explode (battery). Do not store or use near any type of heat source, especially temperature above 60 °C or in an explosive atmosphere.

The device should be switched-off during transportation. The on/off button has to be protected during transportation from turning on itself caused by shock or vibration.

Do not spill any biological samples on instrument components. If spill occurs, disinfect the instrument immediately following the laboratory protocols and the cleaning instruction of the instrument.

Unpacking, Installation and Positioning

Check the contents of the package against the delivery note. If any shortages are discovered, inform your supplier immediately.

Application Installation

The Photopette[®] operates with Photopette application, which is available and pre-installed on the tablet supplied in the packaging together with Photopette and accessories.

NOTES:	 Photopette[®] Application can be downloaded through App Store[®]. Subsequently, users can start using the Application for their measurements.

The device can only run using our Application available on App Store[®]. It is not compatible with other applications.

Measurement data is stored locally in the smart-devices' database and can be exported to .csv file format. It is highly recommended to frequently backup the data from the Photopette[®] application.

Sample Measurement Workflow

- 1. Switch on Photopette.
- 2. Start the Photopette app; enable Bluetooth.
- 3. Under "Device" connect with Photopette.
- 4. Under "Measurement type" select "Wavelength Type" or "Application Type". Use vortexer to mix your sample to achieve a homogeneous sample.
- 5. Attach the CuveTip[™] onto the tip of the device. Ensure it sits tightly on the stem.
- 6. Press "START MEASUREMENT".
- 7. Insert the CuveTip[™] into your blank solution or blank buffer or distilled water. Make sure no bubble stays in the cavity of the CuveTip[™]. Please read our Technical Note "How to use the CuveTip[™] Correctly" available at the Tip Biosystems webpage at <u>www.tipbiosystems.com</u>
- 8. Press "AUTO ZERO" on the app or press the top button on the Photopette device.
- 9. Remove CuveTip[™] from the blank. In case your sample has a large volume of more than 10 mL you can directly insert the same CuveTip[™] into your sample and move the tip for 10 seconds to exchange any blank solution residues with sample. For small sample volumes, tap the CuveTip[™] onto a clean lab paper to remove the blank by capillary force first before transferring into the sample.
- 10. Press "MEASUREMENT" and the absorbance values or concentrations will be shown directly on the screen.
- 11. You can use the same CuveTip[™] to perform additional measurements.

NOTE: Do not overfill the sample vial. This is to prevent samples from seeping in from the top of the sample vial.

NOTE: Check the chemical compatibility chart for the compatibility of the sample solvent or solution you are using. The information is available in the annexure of this manual and on the technical information of the website. Please contact us at support@tipbiosystems.com if the solvent of your sample is not listed on the chart.

Sample Handling Tips

- It is important to mix or vortex every sample right before measurement, if needed, to ensure homogeneity.
- The minimum volume that can be used for sample measurement is 45 µl and can be reused if it is inserted into the tip cavity using a micropipette.



- Proper fitting of the CuveTip[™] is important to ensure accurate measurement.
- In most cases, a laboratory clean wipe is sufficient to clean the device.
- Please avoid touching the tip of the device. •

Battery Operation

The device runs on rechargeable lithium-ion batteries. The batteries can be operated for approximately 12 hours within a normal usage i.e. 20-30 measurement per hour. The device has a charging indicator LED at the top button. The charging indicator will change to green once it is fully charged. When the battery gets low there will be an alert on the application to charge. Once it is below 10% there will be a beeping sound. At this status, it is still possible to use the device for another hour. However, it is recommended to charge the battery at this status. If the battery is not charged there will be a second warning message when the battery is empty and several beeping sounds before the instrument is automatically shut down within 10 seconds.

The battery is a standard Lithium-ion battery with a lifespan of about 500 full charging cycles. Subsequently, the capacity and operation time of the battery may vary. A fully charged battery will selfdischarge over a time of 30-40 days. After this time recharging of the battery is necessary. Charging time for an empty battery is 5 hours.

NOTE: If Photopette[®] shuts down during a measurement process, the data of the last measurement will be still retained in the dataset.

Users should set Measurement Setting before starting measurements. The user can NOTE: view their measurements by dataset names on the Datasets page. In the Datasets page, users can also rename datasets, delete datasets, and share datasets. User can test device performance, change languages (currently English, Chinese and German only) and read "About" in the Setting page.

The Photopette[®] App has a set of pre-programmed applications according to the type of wavelengths present in the device. To select an Application type, go to measurement type to see a list of Application types the user can use.

Buttons



Prior to any sample measurement at the start of a new method, an auto zero measurement of either water or the buffer of the samples is required to give the Photopette a reference of what zero should be.

To initiate the scan of the sample, press the measurement button, the data will be stored in the Dataset until the method is exited at this time the user is able to share or delete the existing datasets.

Before starting measurement, the most important thing to do is to connect with the Photopette[®] device.

Users must **ON** Bluetooth connection in their device in order to connect with the Photopette[®] device.

- *1.* Connecting with Photopette[™] Device (*Figure 4.1*) from the Application
 - a. Measurement Setting » Device
 - Available Photopette[®] devices are listed. Select the correct Device listed.
 - c. If the connection is successful, the device will make 3 beeping sounds and note the tick mark on the right side of the connected device name.
- 2. Renaming Photopette[®] Device
 - a. Users can rename the Photopette[®] device by swiping device name view.
 - b. By right swiping device name view, the Edit button and Disconnect button will appear. (The Disconnect button is only available for connected devices.)
 - c. Please click **Edit** button and fill in proper name at the "Rename" window.
 - d. Click **OK** and the user can see the device name already changed.
 - e. For subsequent connections, the user can see a personalized name on their device. This will help in identifying and differentiating multiple devices.

For instance, if the user chooses dsDNA, 260 nm and 280 nm will be measured. So, the time interval is 4sec. If auto photo is On,

application will need 3 more sec to take photo automatically. So, the final time interval needed is 7 sec.

Please check the battery level often. If battery is lower than 40%, please recharge in order to ensure proper measurement.







Nucleic Acid - DNA/RNA

Measurement of DNA and RNA concentration and determination of DNA and RNA purity can be done by the measurement of absorbance at the wavelength of 260 nm and 280 nm.

In the application, under the Measurement Type, select the nucleic acid category (DNA or RNA).

Calculations

Example:

A DNA sample has an absorbance reading of 0.4. The concentration is calculated as: 0.4 * $50 = 2 \ \mu g/ml$

Nucleic Acids	Concentration (µg/ml) per A ₂₆₀ Unit
dsDNA	50
ssDNA	33
ssRNA	40

Table 1: Calculations for nucleic acid concentration

Purity of	A260/A280 Ratio
DNA	~ 1.8 (approximate value)
RNA	~ 2.0 (approximate value)

Table 2: Calculations for determination of nucleic acid purity

For purity check of nucleic acid, a ratio of A_{260}/A_{280} is used.

A ratio lower than 1.8 for DNA and a ratio lower than 2.0 for RNA indicates presence of contamination. However, the A260/A280 ratio is only an indication of purity rather than a precise answer.

NOTE: Small changes of the pH of the solution will affect the 260/280 ratio. Acidic solution will underrepresent the 260/260 ratio (0.2-0.3) and basic solution will over represent the ratio.

NOTE: It is important to check for the pH of a sample measured on our instrument as acidic and basic solutions will vary the absorbance value.

Direct Protein

In the application, under the Measurement Type, select the Direct Protein.

Total protein concentration can be determined by the measurement of absorbance at 280 nm. This is a simple and quick way of quantification, and the protein sample is recoverable. Proteins absorb light at 280 nm, primarily the aromatic amino acids (tryptophan and tyrosine), and the disulfide bonds (S-S bonds) in the protein sequence. The amount of light absorbs by the protein is dependable on the chemical composition of the protein – the number and type of amino acids. Protein absorption is also affected by the protein structure. Therefore, conditions such as temperature, pH ionic strength, and presence of detergents can affect the absorption of the proteins.

Calculations

To compute the concentration of a purified protein solution, the formulas are given as:

- 1. A₂₆₀/A₂₈₀ Ratio: To check for a pure protein, the A₂₆₀/A₂₈₀ Ratio is approximately about 0.58.
- 2. To eliminate the presence of nucleic acids in the protein sample, the protein concentration can be estimated according to Warburg and Christian formula: Concentration (mg/ml) = $(1.55 \text{ x } A_{280}) - (0.76 \text{ x } A_{260})$
- 3. For better calculation of proteins:

Protein concentration (mg protein or peptide per ml) = (A280 x DF x MW) / ε

Where A_{280} is the absorbance of the solution at 280 nm in a 1-cm cell

DF is the dilution factor

MW is the molecular weight of the protein/peptide

 ε is the molar extinction coefficient of each chromophore at 280 nm

Cell Viability - Resazurin/Alamar Blue™

Tip Biosystems offers the measurement of the reduction of resazurin to resofurin. In this cell viability assay, the resazurin exhibits an absorption peak at 600 nm and the resofurin at 570 nm wavelengths. An alternate wavelength measurement for absorption peak is available at 630 nm.

Resazurin is an indicator dye which incorporates an oxidation-reduction (REDOX) indicator that changes color in response to the chemical reduction of the growth medium of the growing cells. The bioassay can be used to establish proliferation or relative cytotoxicity. The toxicity of related novel agents can be predicted by comparing its baseline data against the baseline data of the known *in-vivo* toxicity.

Turbidity is the cloudiness or haziness of a fluid caused by large numbers of individual particles that are present but undissolved. Determining Turbidity of an aqueous solution is a frequently used procedure to estimate the quality of water. Turbidity is determined by measuring the optical density (OD) at 600 nm since light is scattered rather than absorbed. Careful mixing of the suspension is required before each measurement is taken.

Turbidity - A calibration graph can be plotted using Turbidity 4000 NTU Calibration Standard -Formazin from Sigma Aldrich (Product number TURB4000). The turbidity of the test solution is then determined by substituting the OD value in the equation of the straight line that is determined from the calibration graph.

Turbidity – McFarland for Cell Count

The number of cells in a sample can be estimated by measuring the OD of the cells suspended in a liquid. A calibration curve from the absorbance of known cell density is plotted and the absorbance of the unknown cell density is compared against the calibration curve. This is a quick way to determine the number of bacteria in a sample. The OD value may differ when different types of cells are used. Therefore, the calibration curve can only be used for the same type of cell.

McFarland Standards are usually labeled as 0.5 to 10. They can be made in the lab by preparing a 1% anhydrous BaCl₂ and 1% solution of H₂SO₄ and mixing both solutions at specified volumes and ratios. Commercially available latex beads suspensions are also available.

A calibration graph is plotted from the OD of the McFarland Standards. The turbidity of the test solution is then determined by substituting the OD value in the equation of the straight line that is determined from the calibration graph.

Bradford Assay

In the iOS application, under the Measurement Type, select the Bradford Assay. The Bradford Assay is used to determine protein concentrations. The Bradford reagent contains the Brilliant Blue G dye which will form a colored complex with the protein in the solution. The linear concentration range is 0.1 - 1.4 mg/ml of protein, using BSA (bovine serum albumin) as the standard protein and Bradford reagent (Product number B6916) from Sigma-Aldrich. A standard curve is generated using serial dilutions of known BSA concentrations. An unknown concentration of a protein can be determined by comparing against the standard curve.

The Photopette App has a self-test function under "Settings". The Photopette[®] calibration test is performed with the standard solutions provided in the package. If the instrument passes the self-calibration test, the application will reflect the outcome. If the device does not pass the test, an alert will appear on the application along with the message explaining the reason for the failed test along with the recommended solution.

If the Ok button is selected, the window is closed and the home screen will be shown with an error message at the top. The error message is also shown on top of all other screen and all performed measurements including the saved files of those measurements.
